2. Survey the Lake monthly/seasonally/annually

Here Is What to Do When You Find a Suspected Invasive Species

1. Collect Specimens or Take Pictures

Collect, press and dry a complete sample. This method is best because a plant expert can then examine the specimen

Or --

Collect a fresh sample. Enclose in a plastic bag with a moist paper towel and refrigerate.

Or --

Take detailed photos (digital or film) and send them by mail or email.

Regardless of method used, provide as much information as possible. Try to include flowers, seeds or fruit, buds, full leaves, stems roots and other distinctive features. In photos, place a coin, pencil or ruler for scale. Deliver or send specimen ASAP.

Note Location

(Provide one or more of the following)

- Latitude & Longitude
- UTM (Universal Transverse Mercator) coordinates
- County, Township, Range, Section, Part-section
- Precise written site description, noting nearest city & road names, landmarks, local topography

If possible, give the exact geographic location using a GPS (global positioning system) unit, topographic map, or the Wisconsin Gazetteer map book. If using a map, include a

photocopy with a dot showing the plant's location. You can use TopoZone.com to find the precise location on a digital topographic map. Click the cursor on the exact collection site and note the coordinates (choose UTM or Latitude/Longitude).

2. To Positively I.D. the species send or bring specimen and additional information

- Collection date & county
- Your name, address, phone, email
- Exact location (Latitude/Longitude or UTM preferred, or Township/Range/Section)
- Plant name (common or scientific)
- Land ownership (if known)
- Population description (estimate number of plants, area covered)
- Habitat type(s) where found (forest, field, prairie, wetland, open water)
